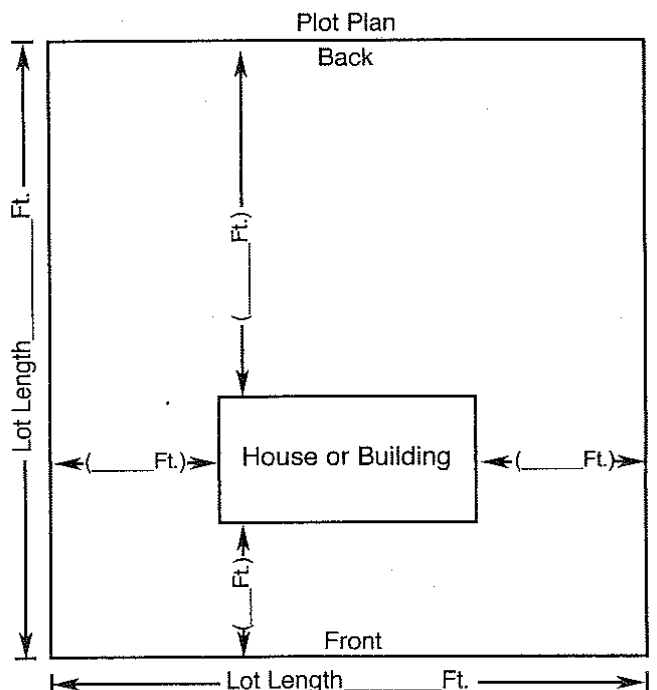

New House, New Commercial Building or Renovation, Addition, Garage, Deck, Fire Repair, Communication Tower, New or Renovated Signs. *(Please review the Building Department Fee Schedule for Plan Review Fees)*
